Information on data processing rules relating to the consent to the use of image

The Personal Data Administrator, that is, the Educational Research Institute – National Research Institute/Instytut Badań Edukacyjnych – Państwowy Instytut Badawczy (IBE PIB) with its registered office in Warsaw, at ul. Górczewska 8, 01-180 Warsaw, tel. +48 (22) 24 17 10, e-mail ibe@ibe.edu.pl, informs that:

- 1) Personal data in the form of a recorded image will be processed pursuant to GDPR Article 6(1)(f) legitimate interest of the Administrator relating to the consent granted for the dissemination of the image, expressed under Article 81(1) 1 of the Act on Copyright and Related Rights for the purpose of posting informational, educational and promotional materials on IBE PIB websites and IBE PIB social media profiles. Giving consent is voluntary, but necessary for the Administrator to publish the image. We will process the personal data contained in the form on the basis of our legitimate interest (GDPR Article 6(1)(f)) in order to demonstrate that consent has been given.
- 2) The Administrator has appointed a Data Protection Officer who can be contacted by e-mail at iod@ibe.edu.pl or by sending correspondence to the above address.
- 3) Data may be made available to entities authorised to do so under the law and to entities entrusted with data by the Administrator for proper service provision only for the purpose and to the extent necessary for these activities.
- 4) You have the following rights:
- a) the right to request access to your data and to receive a copy thereof, the right to request the rectification (correction) of your personal data, its erasure and the restriction of its processing under the terms and in the cases provided for in the GDPR;
- b) in the case of personal data processing for the purpose of pursuing legitimate interests (Article 6(1)(f)), we inform you of your right to object to the processing for reasons relating to your particular situation;













- c) if you believe that the data processing is being performed in violation of the regulations, you have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 5) The data will not be transferred outside the European Economic Area, subject to the transnational nature of data flow within websites/social media.
- 6) Image data will be processed for as long as IBE PIB operates websites and/or social media profiles or until the consent is withdrawn. The data contained in the consent form will be processed for the period relating to the defence against possible claims.
- 7) Providing your personal data is necessary to participate in the event.
